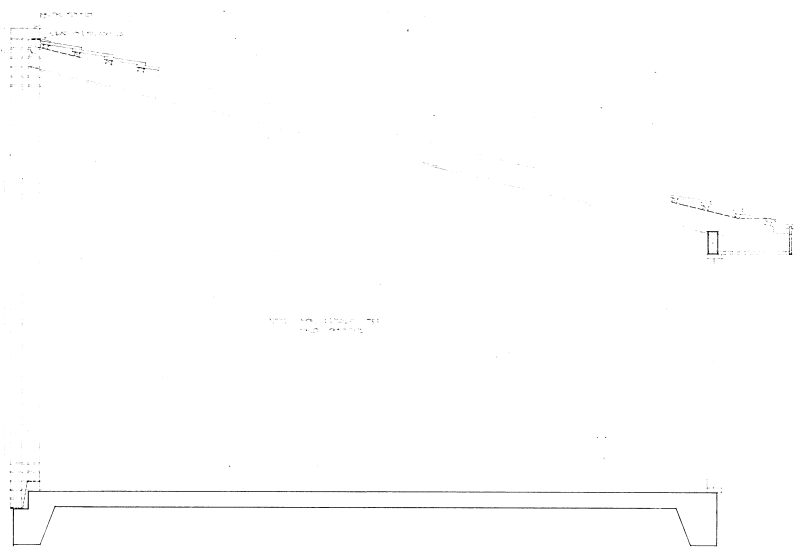

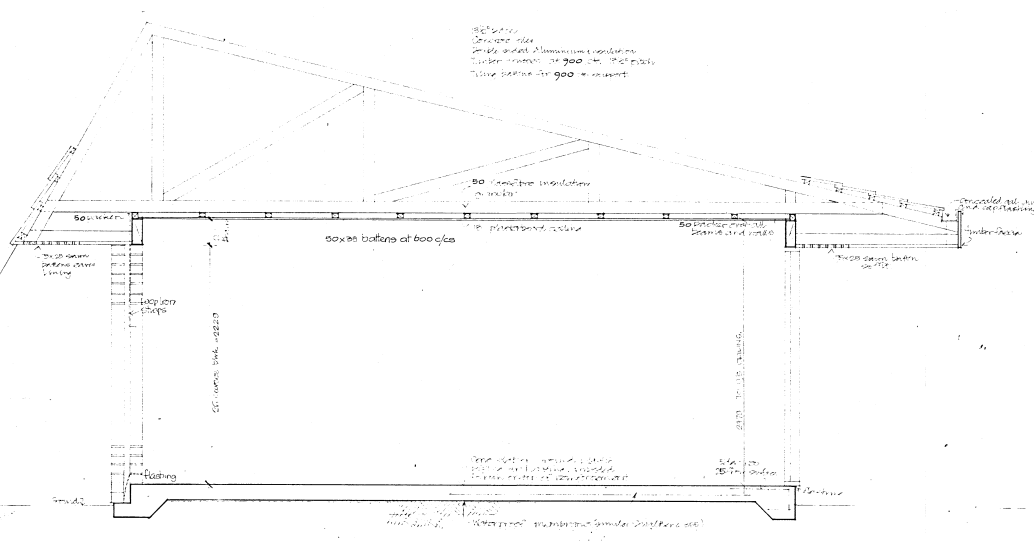

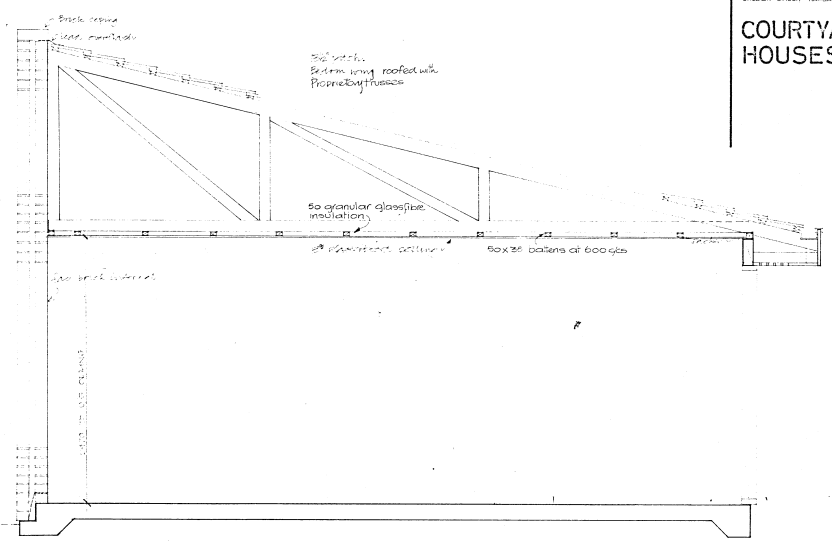
SECTION - SLOPING CEILING THRU' LIVING RM' WING.

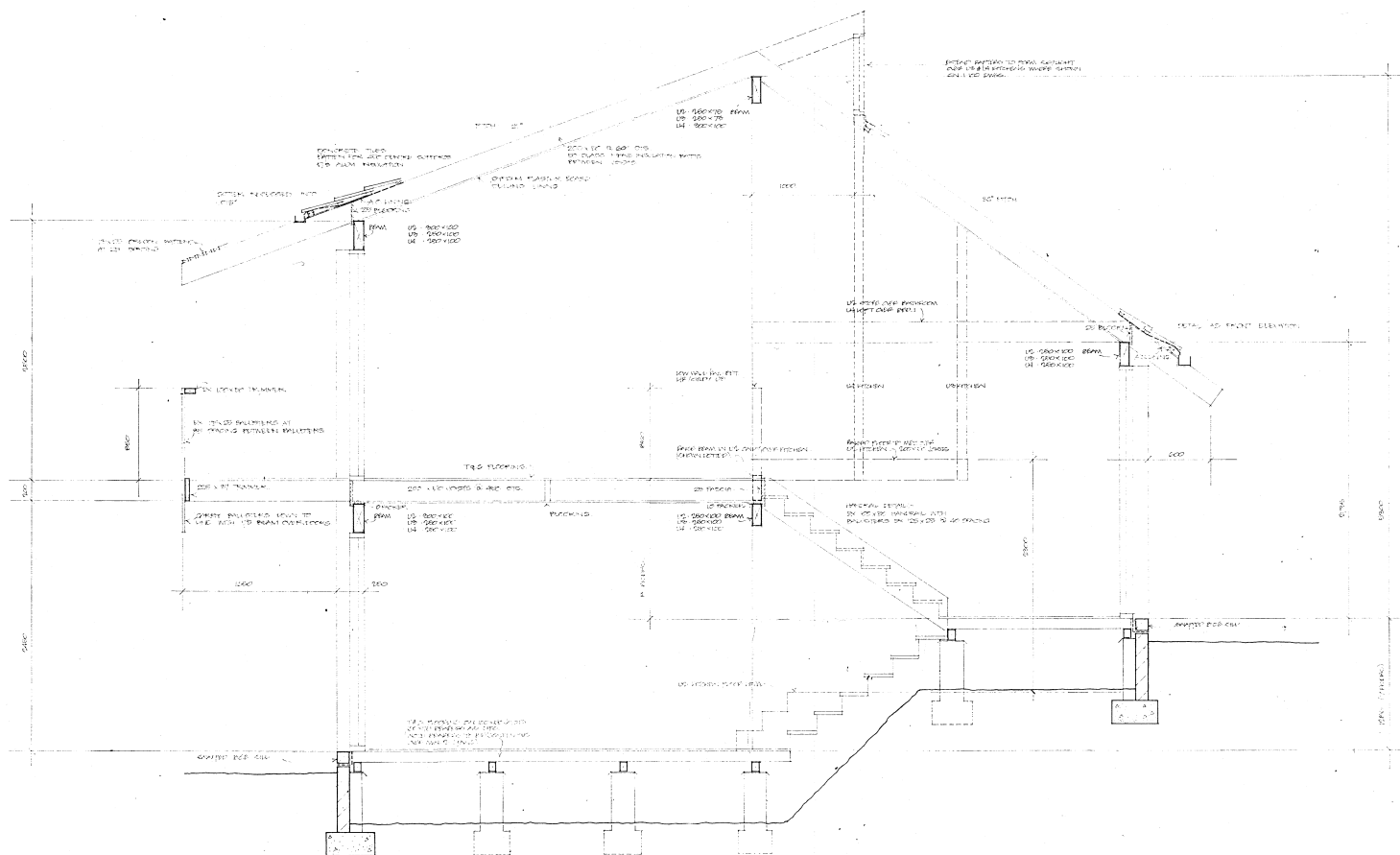
